"To Burn a Draft Card .... "

As a veteran who, like you, gave choice years of his life to the military services of our country, your President is seriously disturbed by the rash of draft card burning by protesting students. Admittedly, the number of such persons represent only a minute portion of our youth. Unfortunately, because this act is sensational, it attracts wide news coverage. More unfortunately, it stamps an indelible mark upon the character of each of these rebellious youth.

In a recent Faculty Forum article for the Daily Collegiate newspaper, Dr. Eric A. Walker, President of the Penn. State University made these cogent remarks concerning the draft card burnings on different campuses throughout the nation. His observations marshall strong counter arguments against these acts and should be mandated reading for all students.

"All of us worry about student protests carried to the point of willful violation of laws. The tragedy of such acts of defiance may not easily be recognized. The real victims are the young people themselves. For when they defy the accepted laws of the land, they mutilate their own careers almost before they begin to construct them,

"To burn a draft card (quite apart from being for or against the draft or for or against war) is a federal offense. When such burning is done, it is in defiance of the law. And the cost of defiance is not just a possible prison term but permanenet damage to a young career and reputation.

"A student by doing such a thing, sets himself apart from a large proportion of the population, He alienates many of his friends and narrows his range of friendships for the foreseeable future. He limits his employment possibilities and circumscribes the scope of his career, not only because his loyalty is suspected, but because his rationality also is questioned. The effect of his act on the world is temporary, but the scar on his career lasts a lifetime.

"That we should be alert to such actions and the causes of such actions is obvious. But we must remember that we choose our students because we think they are bright and we therefore expect independent thinking of them. We hope they are innovators; we tell them that we are not satisfied with the way the world is run and we urge them to correct it, to do something about it.

"Perhaps we should also counsel some caution that, in their desire for change, they do not commit acts that will make them self-imposed exiles in their own land, incapable of sharing fully in the work for which their intellect and education have prepared them.

"If adults seem at times to lack the wisdom to act in a complex world, it does not follow that students still in the learning process necessarily possess it. Their elders may not be as impatient for action as they are, because the elders have learned that arguments are not all onesided. Indeed, a 60-40 split on the facts will make one man say yes while another equally knowledgeable and equally wise will say no.

"It is easy to make up one's mind when the facts are obscure and unknown. But it takes a truly wise man to make up his mind and later, on the basis of previously unrevealed facts, or on more complex evidence, or even on a shift of his own sentiment, to change it. And what is more, it takes courage as well as wisdom to alter a wrong position once it has been publicly announced and publicly defended.

"Our problem seems to be that we cannot persuade our students that there is time to learn all the facts, time to assess them, and time to take a second look before taking action that cannot be erased."
