

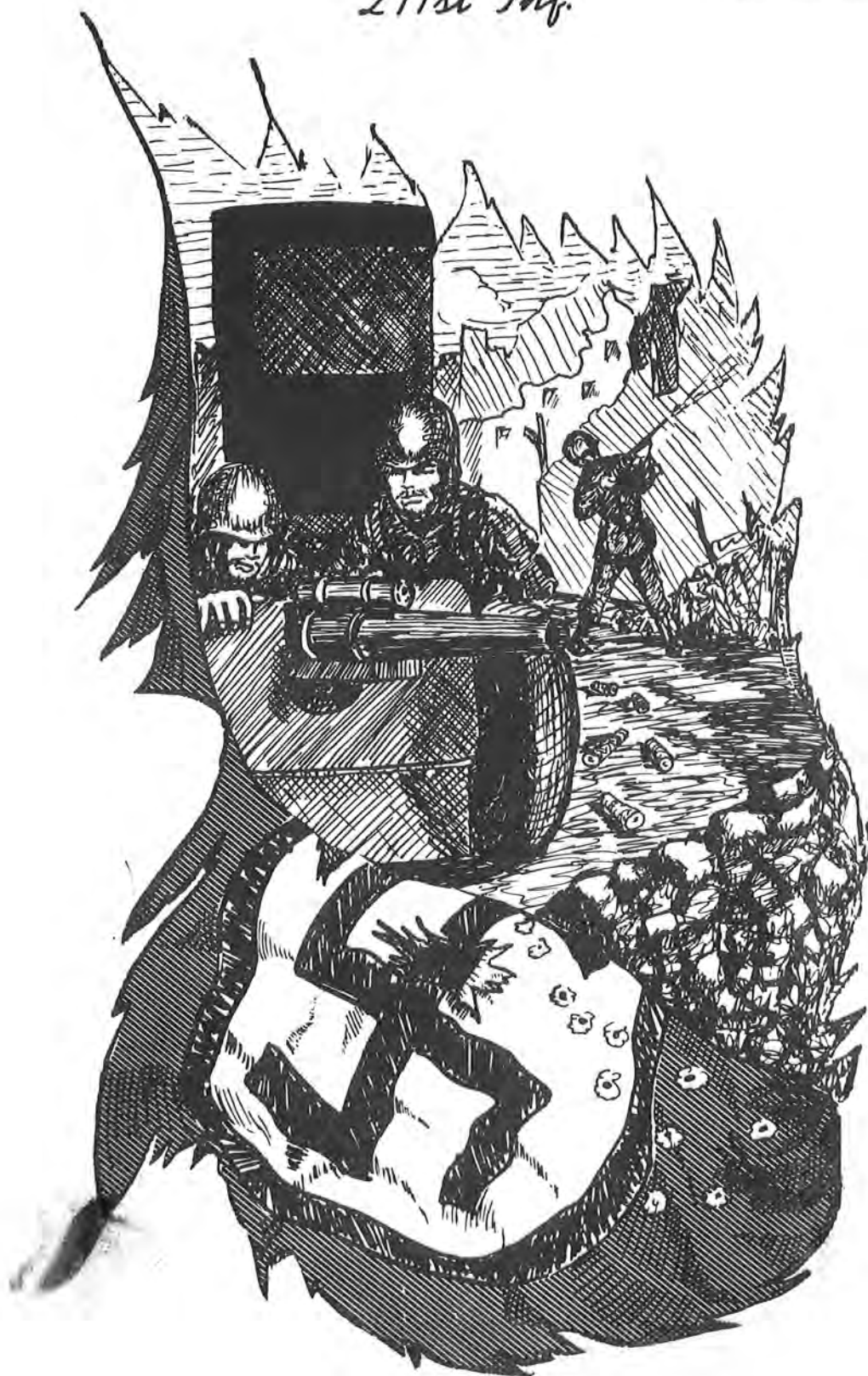

THE COVER

Some time ago it was pointed out to us by Pierce Rice that one of the issues of the bulletin had slipped out minus its title on the front cover. The current issue, it would appear, makes up for this past omission by having two titles.

Actually, today's cover is the cover illustration for a publication which we received in the mail recently, all the way from Maag, China, believe it or not. The sender was Col. Arthur R. Datnoff (Captain, while with AT-271) who had it printed after carrying around a copy of the manuscript for some 22 years.

What is "it"? "It" is a complete history of Anti-Tank Company, 271st Infantry, from the date of activation through to the exchange of personnel with the 29th Division in July 1945. The following is the preface:

"PREFACE

The History you are about to read began twenty-one years ago, almost to the day. Nineteen years ago the Author, Reuben Levin, entrusted the original manuscript to me and expressed the hope that one day it might be published.

The manuscript has traveled widely since 1945 and has waited patiently in dark closets and beat-up lockers. Now, again in Germany, where its story matured, it is being published.

It is a fine record, well told. It is a soldier's story, as a soldier chose to relate it. Except for minor changes the manuscript is exactly as Reuben Levin wrote it.

I hope that each of you will feel the same sense of pride in the accomplishments of our country's citizen-soldiers as I felt in each reading of the saga of Trespass 41.

The text is one of the most detailed factual accounts of the exploits of an Infantry company we have ever seen. It describes the day by day activities of the

unit, from beginning to end, and abounds with exacting information regarding places stationed, dates (even time of day), names of personnel and various relatively minor incidents involving portions of the outfit, right down to details of the death of the company mascot, a brown dog.

There is an appendix which lists all decorations awarded to company personnel, locations of the Company C.P. (with dates), and a roster of company personnel, complete with ranks and 23 year old addresses.

"After 22 years I got the enclosed printed. Please tell your readers I'd like newer addresses than those on Page 91. I have gratis copies to send to old ATCO members.

I'm currently Chief of the Advisory Team on Quemoy and will be here until next 1 July."

We sorely wish there were other unit histories in existence such as this, but then, for all we know, perhaps there may be. --- And perhaps it may not yet be too late for some would-be authors to start now, even at this late date, to set down on paper and preserve for posterity, the unique and unequalled exploits of the maternal unit which remains dear to their own hearts.

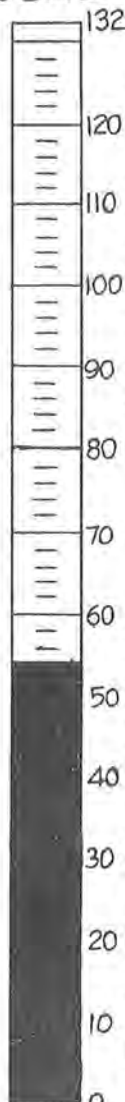
JOIN THE FLIGHTING 69TH TOUR NOW

MAIL CALL

The following are excerpts from a long letter received by Bill Matlach from Col. Gordon D. Ingraham G-4 of the 69th. We regret that space does not permit printing it in its entirety since it gave quite a bit of information on the background and original activation of the 69th as well as Col. Ingraham's later experiences in the Army. Col. Ingraham writes:

"---If circumstances permit, I intend making the next one (reunion) to be held this summer in Philadelphia - and who knows, perhaps that of the following year of the Flighting 69ers. On this I'll have to make up my mind later - after reviewing the Ingraham exchequer.

Did you know, Bill, that I served longer (by two weeks) with the 69th, than anyone - officer or enlisted man. This was when I reported in (as the then 5th member of the 69th) in February, 1943, as the new AC of S, G-4 to General Bolte in Washington, D.C. Ahead of me there were, of course, General Bolte, --- Floyd Parks, our Ass't. Div. CG, a colonel, whose name I cannot recall, nominated then to be the Artillery CG, and Gus Braun, our new Chief of Staff.

---General Bolte and Parks, and Colonel Braun and the Artillery colonel (Later succeeded by BG Uncle Bob Marais) all left the 69th before we went overseas, and I had the honor under General Marais --- to return with the division as its Chief of Staff, and OK the deactivation order at Camp Kilmer.

--- We can be pretty damned proud of our top officers. General Bolte, when I reported in, was a one star Brigadier - later with 3 stars as Deputy Chief of Staff, --- later with 4 stars as Commanding General all American Troops in Europe, and later with his 4 stars as Vice Chief of the Army - the Number Two man! /

Did you know that Major General Emil Reinhardt, who took our division overseas - with one of the finest records of any ETO US Army division - commanded a Corps in the States (that's a three star command) and because an Army order had just come out that hereafter, all Corps Commanders would be selected from ETO 2-star division commanders, General Reinhardt ASKED TO 'STEP DOWN' - although he never so considered it to command a division - the 69th about to go into combat.

General Floyd Parks --- retired --- as a three star general as Commanding General

of Fort Meade, Maryland.

Every one of our original Regimental Commanders --- wound up as, and retired as two star Major Generals. Gentlemen, I and all 69ers salute you ---

How about the division itself? Prior to joining the Pre-Activated 69th I had been on the Staff of the III Corps --- the III Corp was left in Atlanta with the responsibility of inspecting for combat serv-icibility - some 12 to 15 divisions --- This later gave me an opportunity, without the usual pride of one's own outfit, to impartially judge the 69th.

---a personal letter to Parks from one of his Department of Army G-3 friends, whose duties were to inspect divisions for combat readiness --- his comments I can quote in general substance, as follows:

"Dear Floyd:

For the first time, in the 69th Division, after inspecting dozens and dozens of divisions that have completed their maneuver phases of training for combat readiness, I have found those guide lines and precepts, as prescribed in our War Department Plan for the 'Building of an Infantry Division' carried out perfectly in every respect."

I asked General Parks permission to have it printed in the Daily Bulletin - and there it stands as a tribute to a magnificently trained division. At that time --- (and I had had plenty of experience in also checking, from a Corps level, some 10 or 12 divisions) I would have matched the 69th Infantry Division against the famous Big Red One, then considered tops!

---I went out of the army in February 1946 - then back in again in July of that year. In four years I got my permanent Eagles in the Regular Army - had a year in Tokyo, a year at Ft. Ord, Chief of Special Projects, G-2, Europe, C.O. 7707 European Command Intelligence Center, --- orders detaching me to CIA in Washington --- A short tour there, then for the last four years the command of an Army Post of some 10,000 soldiers and civilians. A very satisfying additional 10 years in the Army as a Regular.

--- Still happily married to Suzanne, our daughter Michele now married. After 9 years in association work in international trade, I got fat and again retired in 1965.

Got rid of the lard, passed the rather stiff California Real Estate Salesman's examination - and have my office up in the pine - studded Oakland hills near where I live.

--- If nothing comes up, expect me

OBITUARIES

JOSEPH H. GARDNER (3rd Bn. Hq.) - passed away Jan. 27, 1967 in Tacoma, Wash. of obstructive emphysema and massive gastro-intestinal bleeding from ulcers. Major Gardner is survived by his wife, Sylvia (a Belgian war bride) and three children aged 18, 14, and 12.

During his service with the 69th, Major Gardner was Executive Officer of the 1st Battalion 273 at Camp Shelby and later became Executive Officer of the 3rd Battalion prior to going overseas. He is also believed to have been engaged in a regimental supply position subsequently. He was wounded in May 1945 and was returned to the States for recuperation. He returned to Europe in March 1946 where he served with the American Graves Registration Command in Liege, Belgium, Berlin, Germany, and Nancy, France through June 1949.

Mrs. Gardner is searching for 69-ers who served with him, for the purpose of establishing that the emphysema of which he died was service connected so that she may obtain educational benefits for her children. Major Gardner contracted bronchitis during combat and stated many times that he felt this was the cause of his continuing lung problem. If any reader knew Major Gardner personally and can offer information regarding his health while with the 69th, such information would be invaluable to Mrs. Gardner and her children. JOSEPH J. GLADYSZ (Div. Hq. Band) - died February 14, 1968 at Manchester, N. H. after a long illness. Joe was a well known band leader and musician and had been leader of the 172nd Field Artillery Division Band as well as leader of the 69th Division Band. He had been a chief warrant officer in the U. S. Army for 37 years before retiring in 1957.

Joe was born in Krosno, Poland and has been a resident of this country for 55 years. He was a parishioner of St. Hedwig Church and held membership in the TTK Society, St. Joseph Society, and Casimir Club, Polish Legion of American Veterans Ukrainian Club, American Veterans Manchester Post No. 79, Band Leaders Association of U.S., and Verdon Barracks 99, Veterans of World War 1. He was the originator and president of Pulaski Monument and proprietor of Gladysz, Inc. in Manchester.

Joe Gladysz was a very popular and respected member of his community, as evidenced by the honors paid him as he was laid to rest. The bearers were all members of the John J. Gladysz' Band, with a number of high ranking Army officers as honorary bearers. (John J. Gladysz, Joe's son, was also a member of the 69th Division Band.) Attending church services were Manchester Mayor John C. Mongan, Maj. Gen. John Jacobson and a large number of dignitaries and representatives of the many organizations whom Joe had befriended. The 39th Army Band led the funeral to and from St. Hedwig Church. The final salute at the military funeral was fired by a squad from the 3rd Howitzer Battalion 197th Arty.

NETHERLANDS TO SPONSOR MEMORIAL PILGRIMAGE TO EUROPE FOR
AMERICAN SERVICEMEN NEXT-OF-KIN

The Netherlands War Graves Committee, Amsterdam, has announced that a special memorial pilgrimage has been scheduled to Europe for American Servicemen next-of-kin for May 26th.

Departing from New York via KLM Royal Dutch Airlines, relatives of American Servicemen buried in The Netherlands, Belgium, and Luxembourg will be the guests of the Dutch people for nine days during which time visits to the graves of America's war dead will be arranged and a special memorial service conducted on May 30th.

During their stay in Europe, all participants will be hosted by The Netherlands - all transport in Europe, lodging and meals being provided without cost. Lodging generally will be in Dutch homes.

A complete program of activities will also be provided during their visit to further the "people to people" approach and to acquaint everyone with the highlights of these countries.

Any immediate member of the deceased veteran's family is eligible to participate. This will include Father, Mother, Widow, children of the deceased, brothers, sisters and foster parents. The spouse of a relative would also be eligible to accompany said relative.

The entire program - all-expense - including round-trip air transportation from New York to Amsterdam, lodging, transportation in Europe and all other incidentals except purely personal expenses is offered at a total cost of \$210.00 per person. For relatives who cannot afford to pay this amount, a limited number will be assisted financially by the Netherlands War Graves Committee, as it is the desire of the Dutch to make a trip to the veteran's burial site possible for everyone who wants to do so even if finances are of great moment to that relative.

Through this medium, the Dutch people by their hospitality hope to demonstrate in a positive way the great gratitude to those who, through the sacrifice of their lives, liberated the Netherlands from Occupation in 1945, so bringing back freedom to their country. By this means, the next-of-kin will have an opportunity to see that this sacrifice made by United States Servicemen has not been forgotten.

All arrangements for this pilgrimage are being made by The Netherlands War Graves Committee special United States Representative in Wheaton, Illinois. Inquiries should be addressed to The Netherlands War Graves Committee, P. O. Box 522, Wheaton, Illinois, 60187.
