

# **GENERAL BOLTE PASSES AWAY**

**Bolte, Charles Lawrence 1895-1989**

## **A great soldier died February 11, 1989**

**General Charles Lawrence Bolte**, who organized and trained the 69th Infantry Division at Camp Shelby, Mississippi in 1943 and 1944, died at the age of 93. He served for more than 38 years in the service of his country in grades ranging from second lieutenant to four-star general.

In 1918, he saw action in France with the Fourth Division and was wounded in September of that year. He served in the Army of Occupation and returned to the United States in 1919. **Bolte's** service between the wars included duty at the Infantry School, the Command and General Staff School, the 15th Infantry in China, the Army War College, office of the Chief of the Air Corps and IV Army.

His service during World War II included: In London, England, with the Special Army Observer Group, on the staff of the European Theater of Operations, Headquarters of Ground Forces, and Commanding General of the 69th Infantry Division. He trained the 69th from February 1943 to July 1944 when he was made commander of the 34th Infantry Division in Italy.

**General Bolte** recognized that soldiers must be hardened to the rigors of warfare, and he had his troops of the 69th in field operations so often and so long that they humorously referred to themselves as "Bolte's Bivouacing Bastards" — the "Three B's."

Postwar assignments included: Assistant Chief of Staff, Grounds Plan, Chief of Staff of Army Ground Forces, Director of Special Joint Planning Group in Washington, Director of Plans and Operations Division of the Army General Staff, Assistant Chief of Staff for Operations, Commander of Seventh Army in Germany, Commander in Chief of U.S. Army and Vice Chief of Staff of the Army.

**General Bolte** was awarded these decorations: the Purple Heart for his wounds in 1918, Distinguished Service Medal, the Silver Star, Legion of Merit, plus several decorations from Great Britain, Italy, France, Brazil, Ethiopia and Columbia.

**General Bolte's** wife survives him. His is also survived by a daughter, **Demara**, and two sons, **Colonel (Retired) David E. Bolte** and **Brigadier General (Retired) Philip L. Bolte**.

**General Bolte** attended many of the Annual Reunions of the veterans of the 69th Infantry Division. The final Reunion he attended was in 1987 at Niagara Falls.

A good friend of his, **George Moberg**, is following through on his address, and I'll advise you as soon as we know. The Mobile phone directory merely lists the address as "Turner Williams" which is the name of a road and other things there. The telephone operator said that no further information could be divulged.

**Patton Museum of Cavalry and Army**, P.O.B. 208, Ft. Knox, Kentucky 40121: **Major General Tait** forwarded your letter concerning the 69th Infantry Division patch on exhibit at the Patton Museum to me for response. We were aware of the error in the Third Army Flag which shows the 69th's patch upside down. It is one of a number of errors in the construction of that flag. The flag itself was made as a memento for **General Patton** on the occasion of his 60th birthday, 11 November 1945. Having been made for a special occasion the flag tells a bit of the history of the time just as constructed. It is a basic tenet of all museums that historical objects are not changed to correct errors of fact. At the same time, we, along with the members of the 69th Infantry, are concerned to present the truth along with historical errors. In response to your request we have constructed an exhibit showing the errors on the flag, and presenting the correct information. In this new exhibit your patch is correctly displayed with the red 6 on the top. I hope you enjoy your visit to the Patton Museum in spite of this exhibit. Should you be able to return in the near future, I would be pleased to meet you and show you the new exhibit.

I still have this "dollar bill" and although somewhat frayed after all these years, I would like to return it to him which I think he might like as a keepsake. I only saw him for a moment after that, and I have no idea where he lives. I would appreciate it if anyone knows any information about him, that they would let me know.

If my father was asleep, or unable to communicate when we called, the other patients in his ward would relay to us the information about him.

The reason for this letter is two fold. First, the V.A. Hospital system has gotten bad press lately, and does have its problems. However, in the case of long term illness or terminal illness in the case of a 69th Veteran, the family may consider this as an option. We drove 2 hours each way a day to Fayetteville to visit our father, and found that superior to the local hospitals. Please list my father's name under Taps, and cancel his News Bulletin.

He served with the 69th Infantry Division, and had suffered a long bout with cancer. He retold me many times about the great fellowship at the 69th Reunions. **Alden Beverly**, 30 Crane Avenue, White Plains, New York 10603 — A-273rd: I found **Ed Lucci's** letter to **Charles Altman** in the Bulletin very interesting. (Returning the Bible) It brought back many memories. I remember the collapse of the building in Miescheid. I was a BAR man in the first platoon of A-273rd. Preceding the second platoon's planned assault on the pill box, I had been on two patrols who had tried to knock it out. On the first occasion, we went out under the cover of darkness, but for some reason, withdrew before attacking. The second was done in daylight, and the Germans pinned us before we got close enough. To enable us to withdraw, our artillery shelled the pill box with smoke shells. This allowed us to withdraw, but our other BAR man stepped on a mine and lost a leg. Two of our patrol risked their own lives to carry him to safety. When I heard we were going to make another assault, I was hoping I wouldn't be called on, as I was one of the few who had been out on the 2 initial patrols, and was afraid the third would catch up with me. It was a shock to us when we heard about what had happened to the patrol from the second platoon. I had just turned 19 and this was the first real combat mission we had been involved with. I am not ashamed to admit I was one scared 19 year old who was thankful that I had not been in that fateful third patrol. If my memory serves me correctly, the ironic part of it was that they never did successfully assault the pill box. When we captured the next town, the Germans had abandoned it.

**Noble P. Casey**, 100 Wallhaven Drive, Akron, Ohio 44313 — C-273rd: In Bulletin Vol. 41, No. 3, there was an article about **Lieutenant Dan Shuler**, his death, and his Bible. The Lieutenant was a platoon leader in my Company C-273rd, but not mine. I was in a patrol of 8 that went through Miescheid to check on the next town, Rescheid, and on our return we came back through Miescheid. This patrol was on February 17th, 1945. The next time I was in Miescheid was after the men were killed. Our Company was back in the woods in dugouts. We were called up to help carry out the bodies. I'll never forget that. I think **Shuler's** platoon was sent up to Miescheid so that they would have a full Company there. After over 40 years the dates are rather hazy, but the accident happened between February 17th and February 28th, 1945. The pill box that was mentioned called in a lot of artillery fire on us, and I had a very good friend who was wounded from it. We encountered a lot of machine gun fire from the pill box, and our squad was cut off and pinned down on a hill in the woods. The pill box was never taken, as the Germans had abandoned it after we took Rescheid. I think that **Lieutenant Shuler** was hit by artillery around Hann Munden in April of 1945. I don't remember anyone from his platoon. My platoon leader was **Ethan Holt**. Does anybody know anything about him? **Captain Isaac Lichtenfels** was our Company Commander.

**Frank B. Huff**, P.O. Box 134, Flint Hill, Virginia 22627 — HQ., 1st Bn.-273rd: In the 69th Bulletin (May to August) on Page 37 in the right corner, the picture is just the sign where in other shots I am pictured with a young Russian soldier whose name I do not remember. It was the first picture taken after we got back to Torgau at daylight on April 26, 1945. We had left Torgau on the 25th of April about dusk, so no one was there but the four of us, and two Russians. They were the two that we carried back to the C.P. with us. I never saw **Lieutenant Kotzebue** on either April 25th or 26th. I have pictures from papers and magazines about the link-up. I lost my wife in March, and have been feeling pretty rough since then.

**Edward J. Kosmal**, P.O. Box 11165, St. Louis, Missouri 63135 — I-271st: I hope you will be able to help me with some of the addresses of men who served in I-Company, 271st Regiment. Officers included **Walter Hazard**, **Leipfritz** and **Thompson**. Others are **William Hiett**, **William Jenkins**, **Richard Rick**, **Levi Marks**, **Stanley Pursell**, **Russell Watson**, **James Sellers**, **George Vlad** and **Alexander McCubbin** from Company C-272nd. I realize that I-Company's History Book is no longer available, but I would appreciate a xerox copy if possible.



## Russian Government Honors Delbert E. Philpott, Company A, 271st Infantry

Dr. Delbert E. Philpott, now head of NASA Ames Research Center's Ultrastructure Lab, was recently the recipient of two special awards. The awards were presented to him in Washington D.C. on September 22, 1988. One is a medal for "Victory Over Germany" and the other acknowledges Philpott's contributions to the Russian space missions.

Thirteen years ago, he played a role in bringing about the first joint Soviet American biosatellite mission. He has had four experiments on three Russian spacecraft; two studying the effects of cosmic rays on the retina, one on the cardiovascular system, and one on the reproductive system. This information has been shared and published with the Russians.

The "Victory Over Germany" medal commemorates the 25 April 1945 historic link-up on the Elbe, when Germany's fighting forces were cut in half, effectively signaling the soon to be achieved victory over Germany. In memory of that historic occasion, the Russians requested that the Apollo-Soyuz link-up of spacecraft from the USSR and the United States occur over the Elbe River, the site of the 1945 event. Being in the space program at that time, Philpott had the honor of being a part of both link-ups.

Here are Philpott's recollections of his first contact with the Russians: "Breabeau and I were returning from a forward patrol with German prisoners when I heard a distant motorized patrol approaching from the other side of the Elbe. Not knowing if it would be German or Russian, I ordered everyone into a ditch and even threw some brush over the Germans to avoid being seen. The trucks almost looked American, but the only insignia was a large black cross on a German half track. My heart sank as I contemplated becoming a prisoner of my prisoners. Shooting occurred when they arrived at the bridge. This only reinforced that idea until I could make out helmets and hats being thrown into the air as I looked through binoculars I had taken from one of the prisoners. I double-timed everyone back to the bridge and had the pleasure of replacing the Russians, who were digging out large posts, with prisoners who continued the effort. Everyone was overjoyed to meet the Russians, but none was as happy and relieved as I was to meet them and know I was not a German prisoner and be back with Company A, which had meanwhile joined the Russians.



Dear Earl,

At last summer's Reunion in Lexington I talked to you briefly about elements of the 69th Division shipping to Europe on the John Erikson. I was on that ship with approximately 5000 men who were from the 271st and part of the 272nd Infantry (as I recall). We left New York on November 15, 1944 and arrived in England on November 26, 1944 (at Southampton, I believe.).

## JOHN ERIKSON



During her pre-War days, this ship — built at Hamburg, Germany in 1928 — as the SS Kungsholm for the Swedish-American Line. Upon America's entry into World War II, she entered U.S. service and began operating for the U.S. War Shipping Administration, carrying out Army sailing schedules. Her wartime cruising was truly extensive. She made 27 voyages in the Atlantic and 2 in the Pacific, carrying more than 300,000 troops in all.

Named for a Swede-American inventor of Civil War days, this ship measured 609 feet in length, 78 feet in maximum beam, and drew 29 feet. Gross tonnage: 16,777. A "Motor Ship," she had a diesel-electric drive, twin propellers, and was rated at 15 knots (17.3 m.p.h.) Her wartime passenger full load numbered 5,460 officers and men — in contrast to her peacetime passenger accommodations for 1,575 paying passengers.

Following the War, she was returned to commercial service. In 1947, however, she suffered a severe fire at New York City. Reconditioned, and sailing as the SS Italia, she then entered the Mediterranean - South American passenger service; later, the North Atlantic service. In 1960, this famed, 8-deck liner began tourist trips from New York to the Caribbean, operating for the Home Lines.

In the spring of 1964, she underwent extensive alterations at a Miami shipyard to become a 500-room floating hotel at Freeport, Grand Bahama Island. But after a while this venture did not prove successful. So the following year she was sold to a Spanish concern for \$740,000 and broken up for her scrap metal value.







# Update on the Shuler Bible Story

(Submitted by Edgar A. Parsons (Bud), Company A, 272nd Infantry, 1913 S. Lakeshore Drive, Chapel Hill, North Carolina, 27514)

The May-August 1988 Bulletin described Lieutenant Daniel R. Shuler's Bible being picked up by Ernest A. Jones, Jr., Company A, 272nd Infantry (now of Charleston, Maine) following an accidental explosion in a barn near Miescheid, Germany. Fifty-one men, including all but two of patrol leader 2nd Lieutenant Ed Lucci's platoon, were killed.

Jones has long wanted to return the Bible to any next of kin of Lieutenant Shuler.

Two courses of action were taken to return the Bible. The National Personnel Records Center at St. Louis, Missouri was contacted and the suggestion of Ed Lucci to contact 2nd Lieutenant William D. Robertson then of the Battalion S-2, 1st Battalion who had known Lieutenant Shuler before the war. Dr. Robertson is living now in Culver City, California.

The answer from the Records Center in St. Louis, received in March, 1988, was a form letter stating that they were unable to identify a military service record from the information given. Parsons replied with the information that Lieutenant Shuler was in Company C, 273rd Infantry Regiment, 69th Infantry Division at the time of his death and that his Serial No. was 0-552040. The next reply from the Center, received in May, repeated their inability to locate a record of military service from the information received.

A letter was received by Mr. Parsons in March, 1988 from Dr. William Robertson stating that he had known Dan Shuler, but did not know him well. He stated that they were in a group of about 80 men who finished basic training at Camp Roberts, California, passed OCS tests, and were awaiting assignment. He stated that he thought Shuler was local to the Los Angeles area and thought that he had visited with or spoken with Lieutenant Shuler's parents on his return home in 1945. Unfortunately Dr. Robertson had no recollection of Shuler's address or siblings. Shuler was single, according to Dr. Robertson and he stated that Shuler was killed in action at Hanover-Munden and not at the Siegfried Line.

In June, 1988 Mr. Jones and Mr. Parsons met in Bangor, Maine. This was the first they had met since July, 1945, when they were near Hersfeld, Germany when the men of the 69th Division were being deployed to other units for the invasion of Japan later than year. After reminiscing about Jones' platoon leader, Lieutenant Bruce Pearson and other men from Company A, 272nd Infantry, (Guy Steele, Robert Walton, Allen S. Whitehead, James F. Batten, Robert L. Anderson, Vaughn Fairbanks, Harold F. Patchen, Anthony Nicholais), Jones gave Lieutenant Shuler's Bible to Parsons.

On examining the Bible, Parsons noted that it was distributed by the Christian Science Publishing Society, suggesting that Lieutenant Shuler may have been a Christian Scientist. Also noted was the signature of the "presenter" of the Bible. The first name might be Lee or Leo or perhaps Lea. The last name might be Andrus or Andrews or perhaps another name.

Jones asked that Parsons take the Bible in the hope that he might be more successful in finding a person with some relation to Shuler.

After the publication of the May-August Bulletin, Parsons received a reply to his story from Isaac Lichtenfels, Lieutenant Colonel, Infantry, Retired, who lives in Asheville, North Carolina. He had been a captain commanding Company C, 273rd Infantry. Mr. Lichtenfels stated that Lieutenant Shuler had commanded a platoon of Company C, 273rd

Infantry which Mr. Lichtenfels had commanded. His letter states: "Our battalion (1st Battalion, 273rd Infantry) when the Division was held up across the river from Hanover-Munden, was given the mission of crossing the smaller rivers which were tributaries (Werra, Weser, Fulda) crossed the first stream about five miles upstream at a little place called Seele, and with C Company, in the lead, proceeded with the mission of taking the autobahn bridge over the second tributary. The Germans tried to ambush us as we came near the edge of the roads where the trail joined the autobahn. After a short fire fight involving Lieutenant King, a BAR man and two scouts, myself and Davey (?) Osborne (Map Sergeant) they surrendered, and the Battalion marched to the bridge, which had been blown.

"Next morning we crossed on pontoon boats, C Company leading again, climbed a steep ridge and came out overlooking and behind Hanover-Munden. Lieutenant Shuler led his platoon down the other side of the ridge in pursuit of about twenty German reinforcements and got into the woods squarely behind the town. His platoon was receiving mortar fire and he personally set out to find and destroy the mortar and crew — the mortar crew got him instead.

"I was still on the ridge and unable to reach him by radio. One of his men ran up and told me that he was killed.

"The fight for Hanover-Munden ended when, fearing for the platoon's safety in case of a counterattack, and fairly sure that the last building in town (the biggest and tallest) would be German Headquarters, I asked the artillery for one round to set that building on fire. The results were spectacular and the fight was over.

"I think Lieutenant Shuler's family lived in California. I do not believe he was married.

"Lieutenant Colonel Saladin, our Battalion CO, wrote up the posthumous reward — I'm not sure, but I think it was a Silver Star.

"The above happened, I think about a month or six weeks after Miescheid. I hope the above proves useful."

Lieutenant Colonel Lichtenfels continues in a postscript to say that they were ordered to be east of a certain grid by midnight. After calling on the artillery to suppress a lot of small arms fire, they walked in and he discovered that this was where his grandparents had lived and where one of his uncles was born.

Parsons checked records at UCLA but was unsuccessful in finding any helpful information.

His next step was to write a letter to the LA Times giving them a copy of the 69th Bulletin and the letter from Colonel Lichtenfels. The Times printed the story of our search on September 18, 1988. A copy of that story was picked up by the Veterans Administration, Department of Memorial Affairs in Washington, DC and because the news story did not include Parsons' address, sent a letter to Clarence Marshall. The letter stated, in part: "Our records indicate that Lieutenant Shuler was interred at Golden Gate National Cemetery on February 1, 1949. Date and place of death: April 8, 1945, Holland. Golden Gate National Cemetery is located at 1300 Sneath Lane, San Bruno, California. Mr. Dennis E. Kuehl is the Director at Golden Gate and he may be able to assist in locating next-of-kin."

The letter was forwarded to Parsons. Without knowledge of the reinterment of Lieutenant Shuler's remains in Golden Gate Cemetery, the Times reporter Dick Roraback printed a follow-up story on October 9. Parsons did not know of the second story until later in October when a friend sent him a copy. He then contacted the San Francisco Chronicle and Examiner, asking them to attempt to find a next-to-kin.

The newspaper ignored the request. He called the Los Angeles Times reporter and told him the burial location information. No further reply has been received. Roraback did provide the information that he had talked with the 28th Church of Christ, Scientist, and learned that a Mrs. Frieda Andrus had been a member in the 1950's and believed the church may have more information about the family. However the information obtained was not helpful.

Mr. Parsons admits the leads are getting slim, but vows not to give up. He asks that a 69er in the San Francisco area contact Mr. Dennis Kuehl at Golden Gate Cemetery, San Bruno (412/589-7737) and check some newspaper files and local libraries. Among the possibilities are newspaper stories around February 1, 1949, concerning Shuler's final burial. The stories might include the names of those attending the services. Reference to local phone books may clarify the fact that Shuler's parents are deceased, or other leads may develop.

It has been determined that Lieutenant Shuler's mother, Nell Shuler, has or had a sister living in Scottsdale, Arizona, but there is no knowledge of the name.

# A Day in April

It's been a long time, but every year as April showers herald the advent of spring, my thoughts go back to that other day in spring in 1945.

It was April and the Germans were retreating, with the G.I.s of the 69th Division close on their heels. Our major and final objectives were Leipzig and the Torgau River, where we were to make contact with the Russians. There were no bugles blaring, flags flying or fellows wisecracking. No — it was up at dawn, out of defensive position, gulp a fast breakfast and push off. We would plod along from early morning till dark — too tired to converse in more than grunts and short terse phrases — halting only when we ran into resistance. In the evening we would stop to rest, dig defensive positions and sleep as best we could under adverse conditions.

This particular April day in 1945 we were pushing onward when the word came back that the Germans were entrenched in the village ahead and were going to make a fight of it. My blood went cold and my heart started beating faster from excitement.

Company F was going to slug through the front of the village. We, Company E, were going to hit it from the flank — which necessitated climbing a steep hill. The hill was almost perpendicular and there were times when exhaustion and enemy fire almost made me drop out. Finally we reached the summit. After token resistance, the few Germans left on the hill threw up their hands and quit. We started down the hill toward the village. Four of us reached the bottom at the same time. The other three started over a little knoll that was in front of us. I started after them. I was half way up the knoll when I heard it — shells coming in, our shells. I started forward again but, from the sound, I gauged that they were going to fall short. I slid down to the bottom of the incline and hit the earth. The terrifying horror of being shelled by my own artillery numbed me. The shells hit, just on the other side of the slight hill, where my three buddies were. Their cry of "Medics" came back and the medic went over to see what he could do. We called back to the artillery to raise their range.

My sergeant and several other fellows joined me, and we started into the village not knowing whether the other three were alive or not. A machine gun opened up and again we hit the ground. Again the cry for the medic was heard. Then we were up on our feet and in the village — shooting at every shadow and collecting prisoners as they gave up. As we advanced through the village, I heard the squeak of a shutter and whirled, shooting at the sound and unhinging the shutter with the initial burst from my BAR. I was relieved that the wind, rather than a sniper, had caused the shutter to open, but, I was proud of my marksmanship.

We passed through the town and, about 100 yards west of the Weser River, Lieutenant Bowen told us to dig in as we would probably stay there. My assistant BAR (Browning Automatic Rifle) man and ammo bearer had thrown away their entrenching tools. The three of us then started digging a three-man hole — taking turns with my shovel. A river was directly ahead of us, and to the left was a tremendous expanse of freshly plowed farmland. About 3,000 yards farther to our left was a town and a bridge spanning the Weser. A wood extended

along the edge of this farmland from our village to the one by the bridge. These woods and the river and the two villages were the boundaries of this farmland.

A German artillery barrage suddenly opened up on us from across the river. Joe, my assistant BAR man, and I dove for the slight hole that we had dug. Joe was on the bottom, I was in the middle and Allen, the ammo bearer, was on top. The way we huddled down, I don't think any part of any of us showed over the edge of the two-inch hole we had already scratched out. Then the barrage lifted. At regular intervals, the shelling continued; we kept digging.

After a few hours, word came down that we were to take the bridge intact. Intelligence reported no Germans on the other side of the river. (Then who the hell shelled us?)

We started out across the freshly plowed land — our feet sinking in the earth over our ankles. We were about half way across when all hell broke loose. The Heinies threw everything at us — artillery and small-arms fire. It came from the woods to our left, from across the Weser River to our right and from the village by the bridge on our front. We hit the ground and I dug my face in the dirt and tried to crawl into my helmet. The bullets were smacking all around like a rainstorm.

My lieutenant got to his feet, waved his carbine and yelled, "Let's get those bastards." I jumped to my feet and ran. I dodged around a spot where a bullet smacked into the ground ahead of me. Some shells came in and I hit the ground. They landed behind me and then I heard someone moan, "Help me, please help me, I'm hit." We had always been told never to stop for the wounded on the attack — the medics would take care of them. Again, "Please help me." We got to our feet and started off again — hating ourselves for leaving our wounded buddy behind. The running was rough. Some of us made toward a nearby road for better footing. Two other soldiers reached the road ahead of me and were hit immediately. I swerved back into the plowed ground, realizing what a fine target I would make on the road.

I hit the ground as more shells landed near me. Something smashed into my foot. I reached back and my hand felt a hole in my boot. I brought my hand up to my eyes and saw blood. I was terrified. This was no "million-dollar" wound — this was a bad spot; I'd probably limp the rest of my life. Again I felt my foot, this time with my other hand; there was no blood. I looked at my right hand; the blood came from skinned knuckles. I was so relieved I sobbed.

We kept going, stopping every now and then to fire futile bursts at an unseen enemy, never halting for too long for fear the Germans would zero in on us. One of the other BAR men fired a burst over my head, that came close to hitting me, and I yelled, "Be careful; you trying to hurt somebody?"

The lieutenant in charge of the second platoon had hit the ground when he felt a bullet smash into his gas mask. Seconds later another bullet hit his helmet and came out on the other side without touching him. He jumped to his feet yelling, "Let's go!" As he waved his arm, a bullet went through the exposed fleshy side of his body. With this, he turned to his sergeant and said, "Take over, I'm going to the aid station before I really get hurt."

Lieutenant Brown of the first platoon was very badly wounded and was told to go to the aid station. He refused to go because that would mean leaving his men. Three soldiers of his platoon, fearing for his life, literally overpowered him and carried him to the aid station.

Overwhelmed with fear I wanted to get to a safe place and not move. However, in my mind I was writing a letter to my father, telling him what was happening. I had to keep going because how could I write and tell him I was a coward and not willing to advance with my buddies?

We were close to the bridge when it was blown up. We hit the ground and snuggled close to it for safety. The lieutenant asked for a volunteer to retrace our steps back to headquarters to ask for help, as the walkie talkie was not functioning. For quite some time, nobody moved. Then Gary from the third squad crawled over to the lieutenant and said he would go. He stripped off his unnecessary equipment and took off.

It seemed like ages and then we heard a rumble — tanks, our tanks. Gary had made it. The tanks lined up and blasted the towns across the river with phosphorous shells. Fires broke out and we heard screaming. At the same time, Company F was destroying the enemy elements in the woods. We cheered madly and fired wildly across the river.

After the action our captain regrouped us — those of us still in one piece. He asked us if we would like to go across the river. Mad for revenge, for the clobbering we had been given, we yelled, "yes." I found myself yelling with the rest — even though I couldn't swim. But orders came down that we were to fall back to the village and rest.

Later that evening, trembling with pent-up emotion and humbly thankful that we were permitted to live, we fell back to regroup, rest and get ready to take off again. Tomorrow was a thought that was hard to face — because tomorrow would be more of the same and would differ only in date and locale.

Generally, I slowly pull myself from my reverie and glance around. The realization comes through slowly, ever so slowly, that there are no bullets flying, nor shells landing, nor shrapnel scattering — that there are no Germans nearby on the prowl for me — that the sun is shining and there is peace about me. For a bit it seems unreal and then true reality forces its way through and the recollections seems only a fantasy — which is the only way with which the recollections can be coped.

## Leon Adler Writes:

Dear Fellow 69ers:

For those of you who were in the final stages of our defeat of Nazi, Germany, this is a reminder of something more unpleasant that has had little mention in the Fighting 69th Bulletin.

On or about April 20th, 1945, certain units of our division encountered the shocking results of man's inhumanity to man — the outskirts and the inner camp of Buchenwald. Needless to say, all men were shocked, including top generals down to the lowliest private. Human beings from many nationalities and religions were wedged into wooden huts and set afire while still alive. The few who managed to escape and climb the electrified fence were killed by tanks with machine guns poised outside the compound. It was a sight we who are clear-thinking and compassionate will never forget. Those idiots who say this never happened can check with the 69th Division G.I.'s who saw it with their own eyes. We found doberman pinscher dogs who were trained to bite off genitals and breasts of the hapless concentration camp victims, starvation and cruel treatment of the worst imaginable kind, plus many other atrocities we will never erase from our memories.

### P.S. Some other little known facts about the 69th:

1. The 369th Medical Battalion was the recipient of the blue-ribboned Presidential Citation for "saving many lives under the most difficult situations."
2. The famous Edward R. Murrow (great war correspondent and television personality) was with the 69th Division on that terrible day when so many of our men were shot off tanks at the great monument battle of Leipzig. He gave a vivid report of this disaster.
3. Company A of the 369th Medical Battalion actually received the surrender of the woman mayor of a large town in the Rhineland - Geissen. (Without a shot being fired.)
4. The much-feared Red Army had many horse-drawn wagons pulling "katushas" and artillery. The Russian soldiers were great at drawing their initials with bullets on any wall, etc.
5. On the day that the Germany Army finally surrendered, a last-ditch German plane took off and got tangled up in telephone wires before they could sneak away.
6. Many defeated German soldiers walked for many miles to our lines to try to surrender to the 69th rather than face the vengeful Russian Army.
7. A week after the official surrender, two German soldiers crawled out of the rubble and surrendered to us Medics, saying they were with an "anti-aircraft unit" and did not know the war was over. Baloney!
8. One of the Company A's men died when he drove his ambulance over a bridge - except the bridge had been blown and wasn't there. Unfortunately he died, but his assistant driver didn't get a scratch.
9. At war's end, we found many Italian soldiers who were held in concentration camps and starved - all because the Italians had surrendered to the Allies.
10. At Wiesenfels, Germany, the 69th encountered a formidable obstacle. Spring rains made the Fulda River a raging torrent. Fortunately, at the point of our crossing, it was only about 200 yards wide. However, German "hausfraus" and children opened up suddenly with machine guns from apartment houses on the eastern side of the river. Dozens of infantrymen were wounded and some were on the opposite bank or in the water. The 369th Medical Battalion saved them all under some rough conditions . . . earning the Presidential Citation.


